

# Guardian Top Projects 2025

# REGULATIONS

These Regulations aim to establish the rules and conditions for participation in the **Guardian Top Projects 2025**, under the terms and conditions set out below:

### 1. ORGANIZER AND SCOPE

1.1. Guardian Top Projects is organized by Guardian do Brasil Vidros Planos Ltda, headquartered at Av. Antônio Artioli, 570, Campinas - SP, CEP 13049-900, registered under CNPJ 01.410.577/0007-20, hereinafter referred to as GUARDIAN GLASS.

1.2. Guardian Top Projects covers the entire national territory.

#### 2. **OBJECTIVE**

2.1. The objective of **Guardian Top Projects** is to recognize professionals who use **GUARDIAN GLASS** products and solutions in outstanding projects in design, technology, and innovation.

#### 3. ELIGIBLE PARTICIPANTS

3.1. The following professionals who use **GUARDIAN GLASS** products and solutions in their projects and constructions are eligible to participate in **Guardian Top Projects**, including: glass & mirror processors/distributors, construction companies, consultants, window frame manufacturers, furniture manufacturers, architects, designers, and glaziers.

3.2. Any registration by professionals who are not eligible to participate in **Guardian Top Projects** will not create any legal effect, rights, or expectations of receiving any recognition for their project.

#### 4. **REGISTRATION**

4.1. Interested professionals or companies must complete the project registration and confirm their acceptance of these Regulations and the Image Use License Agreement. If they do not accept these terms, they will not be able to complete their registration for **Guardian Top Projects**.

4.2.1. The project must be completed between January 1, 2022, and December 31, 2024, except for the **SuperClear Award** category (product launch), where the project will still be in the planning stage and must be completed between July 1, 2025, and June 30, 2026.

4.2.2. The project must have used exclusively **GUARDIAN GLASS** products.

4.3. All fields in the registration form must be completed in one go and cannot be altered later. The following project details must be submitted at the time of registration:

4.3.1. Candidate's name; Company name; Full address; Project category.

4.3.2. Photos of the completed project and/or render (3D project), in JPEG format (up to 3 images).

Tip: the more photos, taken from different angles, and with better quality and clarity, the higher the chance of the project being awarded.

4.3.3. In the **SuperClear Award** category, it is required to provide the estimated quantity of **Guardian SuperClear** glass to be used, and to attach a plan or technical drawing of the glass pieces in the project (including dimensions, thicknesses, processing, etc.), along with the render (3D project).

4.3.4. Testimonial about the glass application and the uniqueness of the project.

4.3.5. Details of participants involved in supplying, installing, and deciding on the glass.

4.4. Finalists must submit a video and/or testimonial about the challenges faced in the project, the choice of glass and/or mirrors, and how they contributed to aesthetic distinction and/or technical solutions.

4.4.1. All registrations will be reviewed by **GUARDIAN GLASS**, which may contact participants to request replacement images or modify some registration information to strengthen the application before the voting process.

4.5. There is no restriction or limit on the number of project registrations. Participants may submit one entry per outstanding project.

4.5.1. If different professionals and/or companies independently submit the same project, **GUARDIAN GLASS** will consolidate and unify the information.

4.7. Participants are encouraged to promote their outstanding projects in **Guardian Top Projects**. However, any monetary sponsorship for such promotion will be the sole responsibility of each participant.

4.8. Participants must access the **Guardian Glass** website to access the registration platform.

4.9. The registration form will be available from November 04th, 2024, until February 28th 2025

# 5. PROJECT CATEGORIES

5.1. Projects may be submitted in the following categories:

- (1) Residential Buildings
- (2) Commercial Buildings

(3) Mixed-Use Buildings (hotels, hospitals, shopping centers, schools, mixed-use, and institutional buildings)

- (4) Houses (frames/facades)
- (5) Interiors (use of glass and/or mirrors in decorated spaces)

(6) **SuperClear Award** (a new category in the 3rd edition, for projects in the planning and/or execution stage that specify **Guardian SuperClear** glass).

#### 6. CURATION

6.1. All eligible projects will be presented to associations, industry experts, and media outlets specializing in glass, who will score the projects from 1 to 5.

6.2. The top 3 projects from each category with the highest scores will be presented for public voting.

6.3. Projects will be evaluated on criteria such as technical distinction, aesthetic appeal, creativity, technology, and innovation.

# 7. PUBLIC VOTING

7.1. The top 3 projects from each category will be presented for public voting, totaling 18 finalists.

7.2. Anyone may vote on the projects through the event's voting platform, with the option to vote for one project per category.

7.3. There will be no limit or restrictions on the number of votes for each project.

7.4. Voting will be from April to May of 2025.



# 8. FINALISTS & WINNERS

8.1. All professionals involved in the finalist projects will be invited to an exclusive **GUARDIAN GLASS** ceremony, to be held in São Paulo/SP (or nearby), with the date announced in due course.

8.2. Finalists and winners may use the title **Guardian Top Projects 2025** for promotional purposes. The **Guardian Top Projects 2025** logo will be provided to finalists and winners.

8.3. Winning projects in each category will receive an exclusive trophy as the first-place winner. The other finalists will also be recognized during the event.

8.4. In the **SuperClear Award** category, the winning project will receive up to 1,000 square meters of **Guardian SuperClear** glass, ready for installation.

8.4.1. **Guardian** will handle the processing of the respective square footage. Other costs such as installation, frames, and accessories are not included.

# 9. DATA PROTECTION

9.1. **GUARDIAN GLASS** complies with applicable national and international laws regarding privacy and personal data protection, especially Law No. 13.709/2018 (Brazilian General Data Protection Law), Law No. 12.965/2014 (Brazilian Civil Rights Framework for the Internet), and Decree No. 8.771/2016.

9.2. During the term of this Agreement, **GUARDIAN GLASS** will collect certain personal data from **Guardian Top Projects** participants, such as registration data ("Personal Data").

9.3. Personal Data will only be used by **GUARDIAN GLASS** for the following purposes: 9.3.1. To execute **Guardian Top Projects** and fulfill this Agreement;

9.3.2. To defend **GUARDIAN GLASS**'s interests before participants or third parties in administrative, judicial, or extrajudicial proceedings;

9.3.3. To send participants news, information, and other relevant commercial communications about **GUARDIAN GLASS** products and services, with participants able to opt-out of such communications through a mechanism provided in the message.

9.4. **GUARDIAN GLASS** will maintain confidentiality regarding the Personal Data processed under this Agreement, ensuring that all persons authorized to process such data are expressly and in writing committed to confidentiality and duly instructed and trained for personal data handling.

10.1. The professional or company interested in participating in **Guardian Top Projects** grants **GUARDIAN GLASS**, its corporate affiliates and subsidiaries, and each of their respective directors, agents, representatives, employees, designees, and partners, a royalty-free, worldwide, unlimited, non-exclusive, perpetual, and irrevocable license to freely use the photographs and/or images, including the right to reproduce, distribute, rent, lend, perform, display, transmit, communicate to the public, alter, trim, edit, modify, adapt, create derivative works, and otherwise use the photographs and/or images, in whole or in part, through any media now known or developed in the future, with the right to freely sublicense others to do all of the aforementioned activities.

10.2. The moral right to be credited is not waived, and credit will be provided in use wherever possible.

10.3. The image use license will be valid for an indefinite period.

# 11. GENERAL PROVISIONS

11.1. If any part of these regulations is deemed invalid or unenforceable, the affected provision should be interpreted consistently with applicable law to reflect the original intent, while the remaining provisions remain in full force.

11.2. Any tolerance of breaches of these regulations does not imply a waiver of rights, allowing the tolerant party to demand full compliance at any time.
